- (i) CBDT informed that Direct tax collection for Financial Year (FY) 2023-24 (up to 16 September 2023) Rs. 9.87 Lakh Crore, 18.29 % higher than gross collection for corresponding period last year
 - Vide Press Release dated September 16, 2023.
- (ii) (a) CBDT prescribed for filing application in Form 13 + also generation of certificate for lower deduction of tax when number of payers not exceeding 100
